Our man at The Post

"Contributing to the creation, production, printing, and distribution of one of the greatest newspapers in the United States," is what Bill Liberti '81 loves about his job. He is director of information technology (IT) client services for The Washington Post. Bill joined the paper in 1998 and now manages all of the IT client support system, including the hardware and software for the company's District of Columbia offices, printing plants, and remote news bureaus.

Making it sound like a small leap from majoring in art to publishing, after college Bill took a job with the Department of Defense, where he designed and illustrated pages for daily publications. As publishing became more computerized, Bill mastered those skills, too, and eventually became a publishing group manager. Along the

way he earned a master's in public administration from The American University.

Today he supervises about 60 IT employees and says the staff at The Post "is the best I have ever worked with." Bill often collaborates with the executives, reporters, publication staff, and everyone in between. He credits his college experience with giving him the teamwork skills needed to function in a worldwide organization of over 3,000

His department makes sure reporters have all the tools needed to transmit a story—whether by wire, wireless, or satellite—to their D.C. office. His people are responsible for the systems that allow the electronic creation of every page in the paper. They then transmit them to their plants in Virginia and Maryland.

Reminded of the observation by Confucius to "Choose a job you love and you will never have to work a day in your life," Bill says, "In that case I would only have to work once in a while."

Bill lives in Falls Church, VA, with his wife, Eileen, an eighth-grade science teacher, and 10-year-old daughter, Madeline.

Adella Martha "Tiby" Liebenow Wotherspoon, died at the age of 100 in a Berkeley Heights nursing home January 26. Following graduation from the New Jersey State Normal School in Trenton, she taught for a year at Cleveland High School in Cranford, spent 36 years teaching business administration at Plainfield High School, retiring in 1961. She was known all her life as the youngest survivor of the deadliest disaster in New York City history prior to the 9/11 suicide bombing. At the age of six months, she and her family were aboard the General Slocum, a 264-foot paddlewheel steamboat, when it burned and sank on a church outing to the Locust Grove Picnic Ground on Long Island. A total of 1,021 people died, including Adele's two sisters. When she died, she was the last living survivor of the tragedy. Her husband, James, died in 1982. The couple had no children. The New York Times published an unusually long obituary article on Mrs. Wotherspoon and the Slocum tragedy in its February 4 edition.

Helen M. Sadley (E) taught high school English for almost 40 years, so frequently runs into former students. Reading and education have always been very important to Helen and she is proud of the many educational accomplishments of her family members, many of them graduates of the College. Leonara "Norie" Riddering Burnet (E) and her "Eden Woods" moss gardens at her home in Richmond, VA, were featured in Garden Design Magazine of May-June 2003; The Washington Post of July 3, 2003, and in Virginia Living Magazine of August-September 2003. She was invited to lecture at the 57th Garden Symposium in Colonial Williamsburg last May. Many garden clubs and other civic groups visit her gardens each vear for what she calls "talks and tours." She writes: "This 'work' during my 'retirement' continues to give me vitality and great joy. I perform all the work in my garden myself."

Wilbur Walker (E) (MEd) was honored this spring by the Alumni Association for what was called the "long overdue" acknowledgement of his support for the association and the College. Of animals and artistry

For Beatrice Bork '88, 2003 was a very good year.

Her watercolors of animals—ranging from frogs to cattle with a whole lot of birds in between—were exhibited in nine different venues last year, winning four awards for their outstanding quality. She had work in the juried spring show of the Society of Animal Artists (which only those internationally recognized as among the best are invited to join) that just closed in Colorado.

Fine wildlife art must of course be artistically thought out and composed. But first it must be an excellent representation, anatomically accurate with colors true to nature, age, and gender. Woe betide the painter who adds a feather to a hawk's tail to "balance" the design. Beatrice observes and researches carefully, often working from dozens of her own digital photographs.

Her work carries an appeal well beyond detail. She also invests the scene with emotion, with naturalistic design elements, and symbolism. And then she often titles it with a wry hint at underlying ideas. A group of least terns, for example, one of them an adolescent, is named "It's Just a Phase"; a bird's wing shelters an egg in her award-winning "Expectations."

Beatrice has been at this now for quite a while, convinced

since youth that she wanted nothing more than to paint

animals for a living. Her German-born parents encouraged



her artistry but convinced her to study graphic design and illustration in college so she always would be employable. That worked out well, for she owned a successful design firm in Hopewell for eight years. She still freelances for a number of nonprofits to help pay the mortgage in Flemington as she makes the transition to full-time fine artist.
